MODE OF USE

Moisten a clean, soft cloth with CLEANCOLL and use it to dab glue stains for a few minutes until they soften completely. If the stains are particularly stubborn, leave CLEANCOLL to work for 10-15 minutes and then clean by dabbing without rubbing to avoid altering the shine of the floor. If necessary, repeat the process.

OTHER INFORMATION

Before use, check the compatibility and resistance of the paint or laminate to the action of CLEANCOLL. Do not rub the glue residues under any circumstances, as the mineral charges contained in the glue could act as an abrasive and irreparably damage the paint. It is advisable to air the rooms after use.

INSTRUCTIONS
