

# **PROMOX**

ADHESION PROMOTER ON SMOOTH SURFACES FOR EPOXY AND POLYURETHANE ADHESIVES

## **DESCRIPTION AND USES**

PRODUCT FOR PROFESSIONAL USE ONLY

Adhesion promoter based on silane polymers in alcoholic solution. It improves the adhesion of two-component adhesives on very smooth surfaces such as marble, palladiana, industrial floors with quartz finish or ceramic, glazed, vitrified surfaces, etc. Suitable as specific thinner for EPOPRIMER and, if necessary, for two-component products such as GOMMAPOL, GOMMAPOL L, HYCOL TILE, SIPOL, SIPOL PLUS, SIPOL FREE and SIGEPOX. Absolutely not suitable to dilute polyurethane adhesives. Not to be used as a degreaser or cleaner of old floors.

# **USE MODE**

The substrate must be dry, clean, solid, free of dust and release agents and thoroughly de-waxed and degreased. Apply PROMOX adhesion promoter on the whole surface evenly and in a thin and continuous layer using a clean cotton cloth dampened with product. After complete drying proceed with gluing with two-component polyurethane or epoxy adhesives.

# OTHER INFORMATION

Apply a single layer of product without overdoing the quantities indicated. Do not use the product in permanently humid environments or with temperatures below +10°C. PROMOX is absolutely not suitable to dilute polyurethane adhesives such as: LEGNOPOL 2000, GREEN PUR, GREEN PUR PLUS, GOMMAPUR.
